



## **BREEDERS' ONLINE AUCTION TERMS**

This will be an online only sale. Consignments can be submitted via email to [midatlantichighlands@gmail.com](mailto:midatlantichighlands@gmail.com) until April 30. Those consigning animals will need to provide photos and videos of the cattle for the sale website. Cattle will ship directly from the consignor's farm. Semen will ship directly from the Storage facility. Buyer is responsible for shipping. Commission levels are 8% for live animal sales & semen and 4% for no sales. If no bids are received for the animal or semen, so cost will be incurred.

**ENTRIES:** Consignments will be accepted on a first-come, first-served basis. The committee will "jury" the sale so the genetics on bulls and semen are unique. The committee reserves the right to determine the final lots and the lot order. We have openings for 25 registered females, 5 registered bulls and 5 units of semen. Unregistered stock will be considered after registered stock, but not guaranteed entry into the sale. Entries may include cows, bred or with calf at side, open heifers, heifer calves, Bulls over 6 months in age, virgin bulls or experienced bulls. All bulls MUST had DNA testing completed at time of Auction. NO PENDING REGISTRATIONS ARE ALLOWS at time of sale. No steers.

We ask in order to drive sales at the auction, that semen lots DO NOT sell the consigned semen until after the sale. Furthermore, once an animal is consigned it cannot be sold in private treaty. We also remind you that while we will do our best to advertise your lots for sale, we also rely on the sellers to advertise their own lots.

Mid Atlantic Highland Cattle Association, its Board Members and its membership are not liable for the misrepresentation of any lot offered in the Online Sale. **FEES:** \$50 for non MAHA Members, \$20 for current MAHA Members. Entry fees are non-refundable. The last bid received via the online sale constitutes the basis for the commission charge, which is in addition to the entry fee. Animals who are sold will be charged 8% commission. Animals who do not meet the reserve set by the seller will be charged 4% of the last bid placed on the animal. If no bid is placed, no fee will be charged. ANY FEES TO COWBUYER MUST BE PAID BY June 15, 2024. No exceptions.

Any animals withdrawn after April 30, 2024 will be assessed a \$100 cancellation fee, in addition to the entry fee they already paid. Substitution of equal quality will be allowed on a case by case basis.

**ONLINE AUCTION:** MAHA will be providing Live online sales using the services of Cowbuyer.com. Consigners are encouraged to submit photos and videos of consigned animals by May 8, 2024. These videos will be used to advertise your cattle. All cattle should be preferably halter trained, in top condition, and groomed. Cattle of sound disposition, but not halter trained will be considered if easily handled.. Bulls must be halter trained and DNA tested completed. Wild or poorly behaved animals will not be tolerated, nor accepted

**HEALTH REQUIREMENTS:** Seller offers the animals in good faith that the animals or semen are as represented and are solely responsible for the condition of the lots offered in the online auction. Seller will provide an vaccination schedule to the Buyer. Seller will have the animal up to date on all vaccinations including but not limited to BVD and Brucellosis.

Seller is responsible for obtaining a health certificate for any animals sold out of state at Seller's cost. Sellers consigning animals to the sale are responsible for providing the health papers for travel to the Buyers. These Health Certificates (CVI) will be provided to ALL buyers regardless if within State travel. CVI must be written no more than 30 days prior to pickup and must meet the requirements of the Buyers State Importation regulations, giving enough time to complete any bloodwork or testing required by the Department o Agriculture of Buyers State. Any advertised bred or exposed cow/heifer will provide proof of pregnancy check and confirmation. Seller must also submit the transfer papers to AHCA no less than 30 days after the pick up of the animal

All animals will ship directly from your farm. You will be responsible to work with the buyer to arrange pick up/shipment. Buyers must take possession of cattle within 30 days of the close of the auction. If you would like to offer to keep your cattle for a longer period of time, you need to work out any arrangements with the buyer .Buyer is responsible for the cost of shipping and arranging transportation.
